Engines & Out Drives:

New Engines and Out Drives were installed in 2007. The following hours have accumulated on each.

Repairs and Upgrades completed in 2009

- 1. Remodeled aft bathroom (paint, floor, vanity, marine head)
- 2. Remodeled forward bathroom (new marine head and paint)
- 3. New drapes in salon and staterooms
- 4. New larger freezer on bow
- 5. Remodeled lower staterooms (paint)
- 6. New microwave
- 7. New trash compactor
- 8. New fluorescent lights on radar arch
- 9. New oak doors on hallway closets

Sound system discussed extensively ref. replacing and directions on use.

2010 Work week planned repairs and upgrades

- 1. Complete oak paneling on switch panel console and stairwell
- 2. New screen doors
- 3. Replace forward bathroom floor, counter, sink, and fixtures
- 4. Replace broken chaise lounges (two)
- 5. New couch* (This will be a comfortable couch, not a hide-a-bed)
- 6. New safety rail canvas
- 7. New BBQ
